- Consolidation of the land in 1806 to what we now know as Cottenham Road Allotments totally 3.67 acres
- At one time there were 80 people receiving the gift of coal from the Charity, this included labouring cottage holders with a preference where there had been illness or large families in poverty. Widows always received the full allowance.

- Coal became difficult to obtain during the war years, the annual gift of coal was changed to money, recipients were them limited to Widows born in Histon
- Gift of over £30k was left to the Charity in a will
- 2004 a request was made to the Charity Commission to change the remit to "The relief of persons resident in the area of benefit who are in need, hardship or distress"
- Trustees changed to two appointed by Histon Parish Council, 1 appointed by Impington Parish Council, two appointed by Histon Parochial Church and one appointed by Impington Parochial Church

Chair's report to 31st March 2024

Last year and the year before, your previous Chair, Denis Payne, began his report for the Histon and Impington Annual Parish Meetings with the lines "We are in a vastly different place to a year ago" — and I really want to say the same again! The Council has changed a lot over the last year, and I feel the change in the last year has been even more startling, not just because I have been sitting in a different chair when I attend the Full Council Meetings.

For, I hope, the many of you who have stayed awake long enough to read my long article 'The day-to-day life of the Parish Council', I will not concentrate my report on what Council has been doing but instead highlight the potential for change going forward, both for the Council and for all of you as members of Histon and Impington Community.

My insight and perspective as to the increasing scope and role that a Parish Council can play in supporting its residents and community is something I did not expect to find when I joined Histon & Impington Parish Council (HIPC) in April 2019. The scope that HIPC is increasingly responsible for is greater than I ever expected, and it is also the reason I have used the same line as Denis to begin my report this year. The role of a Parish Council appears to be evolving at an increasingly fast pace and bringing new challenges every day to our Staff team and our Councillors. I have often said I find the role of the Parish Council in our own backyard of Histon and Impington one of the most exciting, challenging and, in some respects, absolutely ridiculous roles that I have come across. My previous role in the city working with my very favourite topic of data never seemed as challenging as the role of Councillor or the role of Parish Clerk which I have taken on in neighbouring Girton.

This year I have watched in awe as:

- Our Staff team take on significant challenges as a result of increasingly demanding projects and
 possibilities; last year, after a difficult but important discussion where I was presented with the text
 'Stop spending' by my Clerk and RFO, I realised the strength of the Parish Council Office Team who
 are increasingly considering strategic methods of operations to support our ambitious and proactive
 Councillors.
- 2. Our young, vibrant council (well, relatively!) with an amazing beginners' mind try to cut through the impossibilities of change, the impossibilities of tough topics such as Pump Tracks, wide-ranging tree works, Recreation development and anti-social behaviour.
- 3. Both the above teams work together to improve consistency of policy and procedure to support those demanding projects both in terms of scope and funding required.
- 4. An increasing number of professional, committed organisations and businesses in our villages work to raise the bar to ensure they are sustainable and fit for purpose, to service Histon and Impington for the future in services which may have historically been the responsibility of other much larger organisations, including Wellbeing, Recreation, Nature & Biodiversity and Communication.

This ambitious change brings challenges and often frustrations that groups need to work through together to create order, understanding and trust. Having worked through these changing times, this creates greater resilience for organisations with a passion for supporting their communities.

Any community that is courageous enough to step up and to step out of its current state, its current comfort zone and aim for better, has my vote. This is the type of community I would like to see for my family, for my friends, and for my neighbours and this is the type of community that my family, friends and neighbours provide for me every day.

This leads me to what I believe is the most important change I see on Council; certainly, it is my very favourite, heart-felt change. I believe I see a Council that has worked through the 'forming' and 'storming' that always occurs, and is now a council that is 'norming', working together to better understand the challenges of our community organisations and residents. A Council that I have seen work through many difficult conversations. remaining resilient in order to reach the best solution that can be achieved at the time. A Council driven by Staff and Councillors that have a focus on achieving the best for our village even though some of the conversations and debate can be tough for them personally. A Council and community that I believe are working through the difference in their perspectives to deliver better outcomes for our Villages.

I would like to finalise my report in Thanking everyone on this Council and in this Community for all the support you have given me as first, a 'rookie' Vice Chair and, for the last year, a 'rookie' Chair of your Council. It has been one of the best and most painful things I have ever done!

As per my article in HI Hub Highlights. 'Thank you 'Team Histon & Impington.' Let us do better together.'





Public Works Loans: The Parish Council services a series of loans taken out to fund the development at the Recreation Ground from 2005. These loans will be fully paid off in 2030 if the Council does not take out any more loans or merge all the loans together. The payments this year for all loans amounted to £27,917.

Section 106 funds: There are sums of £157,678.83 in various Section 106 funds, which is funding provided by developers which must be spent on specific projects within a 10-year time frame on various community focused areas. We have used these funds for several projects this year, with advice on the suitability of the fund being used obtained from South Cambs District Council.

Earmarked Reserves and General Reserve spend: Earmarked reserves are funds that have been set aside for a specific purpose, such as improvements at the Burial Ground or replacement of play equipment, and these are topped up when needed so that funds are ready for use when the need arises. Where a project or works have not been allocated a budget or reserve, the General Reserve is used to fund the item.

The Finance, Governance and Legal Committee rationalised the earmarked reserves during this financial year, transferring £35,528.47 of earmarked reserves back into general reserves, and introducing a new Reserves Policy to specify how any future reserves should be created. The General Reserve Fund was £498,680.88 at the end of the financial year. The advice from Auditors is to maintain a general reserves fund of at least 50% of annual precept, which for 23-24 would be £205,872.00.

The precept for 2024/25 for Histon and Impington is for £435,828.48 and has increased by 5%. Our expenses budget for 24/25 largely matches the amount requested for precept. The Council's plans for capital projects will need to be partially funded from the General Reserve Fund, and the Finance, Governance and Legal committee will monitor any requests for capital spend in the coming year.

Our main sources of income are from the Parish Precept (the parish part of the Council Tax bill provided by South Cambs District Council), facilities charges including the Recreation Ground, Sport Club fees, Burial Ground fees, allotment fees, and grants. We are keen to obtain more grant funding where available, and are lucky to be the recipients of a donation from the Friends of H&I Community, who run a variety of community events and fundraisers in the village, as well as an ever growing choice of classes in our Community Room such as the Stroke Recoverers Group and Chair Based Activity Class, Table Tennis, Tai Chi classes, Memory & Co-Ordination Group and Dance & Fitness Class. The Council itself financially supports Youth services and the Age UK Village Warden Scheme.
