24/059 059.1	<p>PUBLIC PARTICIPATION</p> <p>Members of the public in attendance for both planning applications on the agenda. 4 members of public had booked a slot to speak.</p> <p>3 members of public spoke in opposition of the planning applications detailing concerns over parking, traffic, floodlights, indications of lack of trust with the applicant, safety concerns with pedestrians and the highway and overdevelopment of the site.</p> <p>1 member of public spoke in support of the applications with the points below:</p> <ul style="list-style-type: none"> - IVC had been labelled as a priority site for development of a 3G pitch, - New car park will alleviate existing problems, - SCDC minded to support the development of a 3G pitch due to interest in using the site for their health referral schemes -development of a 3G pitch will mean that residents will not be travelling outside of the village to access other 3G pitches in the area (Northstowe) but instead will allow residents to access their local 3G pitch via walking or cycling thus reducing car movements and congestion. <p>Dist Cllr Cahn provides advisement that identity of the applicant is not a material planning consideration.</p> <p>21 members of public left at 8:34pm following a miscommunication with Chair Murray regarding whether they could stay observing the meeting. Chair Murray clarified that residents were able to stay and observe the remainder of the meeting but residents continued to leave.</p>	
24/060	<p>COMMITTEE CHAIR COMMENTS</p> <p>Brief verbal report given by Committee Chairs detailing the contents of their reports and the committees professional opinions on matters relating to their remit. Chair thanked each Committee Chair for their input.</p> <p>Debate opens and councillors begin debating existing issues with the IVC site such as traffic, parking and access. Assistant Clerk advises that the Highways, Drainage and Formal Spaces Committee alongside County Council are looking into the prospect of double yellow lines along New Road and the Wellbeing, Recreation and Leisure Committee are also actively looking at ways to reduce the impact that the Recreation Ground has on the traffic issues at New Road. Cllr Uttridge acknowledges the existing issues at IVC regarding traffic and parking</p>	

	but highlights the huge positive impact these facilities will bring to the students and teachers at IVC providing a much-improved learning experience for all. Cllr Leonard expresses dissatisfaction with the proposed car park being retrospective and wishes it to be returned to grass. Cllr Davies notes that the IVC site is practically at capacity.
